### St German's Preceptory No 498, Knights Templar, Isle of Man



E.Kt. Graham Platt, O.G.R., Preceptory Registrar of St German's Preceptory No. 498 was pleased to send us the following:

"Here in the Isle of Man we are in a unique position, we have not had a case of Covid-19 in the local community for over 100 days. Our borders are closed.

Only local residents are allowed to return to the Isle of Man and only if they agree to isolate for 14 days.

Our Preceptory was consecrated on the 27th April 1982 and meets in the west of the Island in Peel. We have a membership of 27 Knights at present.

In September we were given permission to hold our Installation and had a very good meeting with a good turnout of Knights

R.E.Kt. Capt. Eidwin F. Mullan, G.C.T., acted as Eminent Preceptor as the Eminent Preceptor himself was unable to attend.

We had a ballot for two Knights to be installed. The ballot proved all clear so we are looking forward to installing these Knights

Unfortunately due to Covid-19 and the uncertainty if we would be able to hold the installation meeting we were unable to install first Constable John Shakespeare as Eminent Preceptor so instead V.E.Kt. David Downie, *MBE*, P.G.Reg., was invested as Eminent Preceptor, he last having held the office in 1984. Kt. John Shakespeare will be installed as Eminent Preceptor next year when hopefully we will be able to give the ceremony its full justice.

The Eminent Preceptor then invested his officers, then all retired for a full festive board.


St German's Preceptory of Knights Templar meets at Freemasons' Hall Peel, on the second Monday in September (Installation), November and March (Elections). We would welcome any Knights to the Island when our borders are open again."

The Masonic Hall in Peel has an interesting history.

The Strand Cinema Co. (1920) Ltd. opened the Pavilion Cinema in July 1923. It had 400 seats. The external walls appear to have been those of a building used as a grain store. The cinema was built on the ground floor with a ballroom above. Sound was installed in the 1930's.

The Pavilion Cinema was taken over by The Palace and Derby Castle Co. in December 1945 and that company closed it in February 1961. The building was purchased by the Peel Masonic Club who continued to operate it as a cinema. It finally closed in September 1968 and was converted into a Masonic Hall.

## Red Cross Division of Sussex presents £2,500 cheque to Time 4 Children Charity



On Friday 25th September 2020, the R.III.Kt. Paul Rose, Intendant-General for Sussex, attended the Time 4 Children charity HQ, in Haywards Heath, West Sussex and presented a cheque in the sum of £2,500 from the Grand Sovereign's Care For Children Fund on behalf of his Division of Sussex. The Grand Sovereign is the head of the entire Order for England, Wales and its Divisions and Conclaves overseas and Paul, the Head of Sussex, was invited by him to nominate a charity to receive a donation, which clearly was successful.

Paul, accompanied by his Deputy, Andy Knight, was met by the Chairman and Founder, Vicky Chalmers *MBE*, who accepted the cheque on behalf of the charity. The photo shows the presentation, with the Head of the Order for Sussex, Paul Rose, on the left, Vicky in the Centre and Andy on the right.

Time 4 Children was established in 2005, after its Founder, Vicky Chalmers piloted a school project through 2003 to 2004 in mid-Sussex, whilst working for the Children Hours Trust. It became very clear there was little support for many local children in need of having someone safe to listen to them. The project was hugely successful and formed into a charity in its own right. The Time 4 Children received charitable status in October 2005.

All children need to be listened to. There are many children who need the help and support of a "listening ear" which is where the Charity can help. Their volunteer practitioners are trained to listen to children using Reflective Listening and Non-Directive play techniques. Each child is given a weekly one-to-one session where there is the time and space to explore their worries, fears, upsets or anxieties.

The sessions are held in the school where the child attends. The number of sessions can vary according to the needs of the child. Some need short term support and others need a lot longer. Most children average between 15 and 20 sessions, but occasionally there will be a need for more sessions.

The children benefit from increased emotional well-being, self confidence, self-worth & self-esteem, feeling better about who they are and what they can achieve; improved social skills; more able to learn at school.

Paul said he was extremely pleased to make the presentation of the cheque for £2,500 from the Grand Sovereign's Care for Children Fund, as it will be well used and will benefit those using the service. He added that, during his visit, he had been reminded that although there are many children who are suffering from emotional distress, Time 4 children helps to prevent mental health problems spiralling and becoming entrenched in young children.

On Saturday, 26 September the East Midlands District of Royal & Select Masters held a Virtual Business Meeting in place of the Annual District meeting.

A total of 56 Companions logged into the Video Call and the District was honoured by two special guests in the persons of Most Illustrious Kessick John Jones, Grand Master, and Illustrious Companion Dan Heath, Assistant Grand Recorder.

The meeting was opened at 11.00 a.m. by the District Grand Master and the letter granting permission for the Virtual Business Meeting was read out to the Companions by the District Grand Recorder. Following a brief address the District Grand Master then closed the meeting. There was a brief interlude and members then came back together for a social gathering with a suitable liquid refreshment.
