#### RESUMPTION STRATEGY

From 17 May 2021

All Units shall be permitted to return to meeting as mernel.

Units that cannot resume meeting because the members have indicated that do not with to do so at this tiess or are presented from doing so because their meeting, place in not open, may certifie to enable use of the Virtual Business Meeting scheme until it is possible to recommence physical meetings.

It is not yet clear what restrictions or government guidance will replace exacting measures but as soon as those are known, we will mean an update.

#### PERMITTED ATTENDANCE



# **Antique Medals shine through for Essex Mark**



Friday, 9 April, saw the fourth in the series of Zoom presentations organised by Essex Mark Masons.

Following a few moments of silent reflection following the sad death of HRH The Prince Philip, Duke of Edinburgh, the Prov.G.M., Terry Sheern, introduced Essex Freemason and television presenter Mark

Smith, who proceeded to entertain the assembled viewers, numbering in excess of 70 members and guests, to a fascinating and hugely entertaining presentation about his career.

Mark spoke movingly about how he had a near death experience when he was struck by a car, and how he changed his direction in life. He moved from working for NATO to become the director of the Royal Artillery museum in London. This led to his role on the BBC television programme Antiques Roadshow.

As a young man, Mark's interest in militaria - his specialist subject on the Antiques Roadshow - started with four medals. His collection had now grown to be over 7500. Throughout the talk, Mark amused us all with many tales about his interactions with the BBC film crew and the members of the public.

Questions from the members present were answered by Mark to finish what a truly entertaining evening.

The Prov.G.M. thanked Mark for his time and for his excellent presentation.

We all look forward to the final of our current season of Zoom talks in June, when we will hear from American Mason Ben Williams. Details of which will be circulated shortly.
